REQUIREMENTS & ELIGIBILITY FOR THE MONAVIE DISTRIBUTOR CENTRE

- MonaVie Distributor Centres (MDC) in India are allotted to only MonaVie India Distributors
- MonaVie Distributor Centres must follow the Policies and Procedures of MonaVie.
- MonaVie Distributor Centres must fulfill all the requirements of the law to do sales/business in their place with registrations like TIN No, CST No from Sales tax Department etc.
- MonaVie Distributor Centres must have computer, fax, printer telephone, and high speed internet connection at their centers
- MonaVie Distributor Centres must have qualified persons to run the day to day activities of MDC and also to answer the distributor's queries apart from coordinating with the MonaVie Chennai or branch offices
- MonaVie Distributor Centres must have a training room for around 20 people with all necessary facilities for training.
- MonaVie Distributor Centres must service all MonaVie Distributors irrespective of any team or line.
- MonaVie Distributor centres must not involve directly or indirectly in any other network marketing companies or distribute any similar products.
- The total commissions for the MonaVie Distributor Centres on sales PV is maximum of 10% of total PV sold by them. 6% to 8% on Four week sales and PV 1% to 2% on Twelve months sales PV.
- MonaVie Distributor Centre must pay Rs 5,00,000 as deposit for which stocks will be given. MDC's must increase the stock level with additional deposit when the business grows in conjunction with the Distributor sales of that district
- MonaVie Distributor Centre must pay Rs 10,000 after receiving allotment letter from MonaVie which can be adjusted in the deposit amount.
